ORDER SCHEDULING JANUARY 2026
CALENDAR CALL, MOTIONS, PLEAS AND CRIMINAL JURY TRIALS

IT IS HEREBY ORDERED that the cases attached hereto shall report for a two-week session of criminal jury trials beginning January 26, 2026, through February 6, 2026, in the Fayette County Courthouse, Courtroom 2B.

MOTIONS

If an attorney or unrepresented party intends to file a motion that relates to a criminal case on the trial calendar, said motion shall be filed prior to January 1, 2026. A notice scheduling the motion for hearing on January 13, 2026, at 9:00 a.m. shall be filed with the motion. The opposing party shall be served with a copy of the motion and the notice of hearing.

Failure to file a motion prior to January 1, 2026 and/or failure to notice a hearing for the motion to be heard on January 13, 2026, shall be deemed a waiver of the right to file the motion unless a later hearing is expressly authorized by the Court.

CALENDAR CALL

All counsel and defendants who are not in custody shall appear for calendar call on January 13, 2026, at 9:00 a.m. Failure of a bonded defendant to appear at calendar call will result in a bench warrant for his or her arrest.

Defendants who are incarcerated in the Fayette County Jail do not have to appear at Calendar Call unless they have signed plea papers or a trial motion that has been noticed for hearing, as set forth above.

At Calendar Call each party shall announce (1) any plea offers, (2) pre-trial motions in need of hearing prior to trial, (3) time estimates for trial, (4) interpreter requests, (5) filed *Leaves of Absence* affecting the trial calendar; and (6) any matters which might impact the trial. The Court will also be available to take pleas at Calendar Call. Pleas after Calendar Call shall be considered non-negotiated, unless the Court expressly agrees to allow the parties to keep negotiations open for a longer period of time.

JURY TRIALS

Absent directions from the Court to the contrary, all cases that remain pending after calendar call shall report for trial on January 26, 2026, at 9:00 a.m. Failure of a bonded defendant to appear for trial will result in a bench warrant for his or her arrest.
