JURY TRIALS

IT IS HEREBY ORDERED that a two-week session of criminal jury trials is scheduled for the period from June 1, 2026 through June 12, 2026 in the Fayette County Justice Center, Courtroom 2B. All cases not resolved by May 19, 2026 must report on Monday, June 1, 2026, at 9:00 a.m.

CALENDAR CALL

Calendar Call shall occur on Tuesday, May 19, 2026. All counsel shall appear at 9:00 a.m., in person. All bonded Defendants shall appear at 9:00 a.m. Incarcerated Defendants do not have to appear unless they have signed plea papers or a motion that has been noticed for the calendar.

At Calendar Call each party should be prepared to make known or identify any plea offers, pre-trial motions in need of hearing prior to trial, time estimates for trial, interpreter requests, filed *Leaves of Absence*, and any matters which might impact the trial. The Court will also be available to take pleas at Calendar Call.

PLEAS AND MOTIONS


Any attorney or unrepresented party who seeks to have a pending motion heard that relates to a criminal case on this calendar must file said motion by no later than May 7, 2026, notice it for hearing on May 19, 2026, and serve opposing counsel with said notice.

The Court will hear pleas on May 19, 2026, beginning at 9:00 a.m.

Motions not heard on or before May 19, 2026, shall be deemed waived unless a later hearing is expressly authorized by the Court.

Pleas after May 19, 2026, shall be considered non-negotiated, unless expressly permitted by the court as negotiated pleas.
