CRIMINAL PLEAS AND MOTIONS

Any attorney or unrepresented party who seeks to have a pending motion heard on **Friday, February 13, 2026**, must notice it for a hearing and serve opposing counsel with said notice no later than **Friday, February 6, 2026**.

The Court will hear pleas on **February 13, 2026**, if needed.

Motions not heard on or before **February 13, 2026**, may be deemed waived unless a later hearing is expressly authorized by the Court.

Pleas after **February 13, 2026**, may be considered non-negotiated, unless expressly permitted by the Court.
