Any attorney or unrepresented party who seeks to have a pending motion heard on Thursday, September 3, 2026, must notice it for a hearing and serve opposing counsel with said notice no later than Thursday, August 27, 2026.

The Court will hear pleas on Thursday, September 3, 2026, at the conclusion of the Motions calendar.

Motions not heard on or before Thursday, September 3, 2026, may be deemed waived unless a later hearing is expressly authorized by the Court.

Pleas after Thursday, September 3, 2026, may be considered non-negotiated, unless expressly permitted by the court.
