JURY TRIALS

IT IS HEREBY ORDERED that a two-week session of criminal jury trials is scheduled for the period from August 17, 2026, through August 21, 2026, and August 24, 2026, through August 28, 2026, in the Fayette County Justice Center, Courtroom 2A. All cases not resolved by August 3, 2026, must report on Monday, August 17, 2026, at 9:00 a.m. All cases not resolved by August 21, 2026, must report on Monday, August 24, 2026, at 9:00 a.m. Unless otherwise instructed by the Court, every case is on 2-hour call during trial weeks. Defense Counsel, if the Defendant you represent is incarcerated and wishes to have their case heard at trial, you are required to have a change of clothes for the Defendant at the Fayette County Jail no later than Friday, August 14, 2026, so they may dress appropriately for their trial.

All attorneys or unrepresented party shall submit proposed *Voire Dire* questions no later than 5:00 PM August 10, 2026, for the Court's review. The questions shall be numbered and shall include the style of the case on the top of the first page.

CALENDAR CALL

Calendar Call shall occur on Thursday, August 3, 2026, at 10:00 a.m.. All counsel shall appear at 10:00 a.m., in person. All bonded Defendants shall appear at 10:00 a.m. Incarcerated Defendants do not have to appear unless they have signed plea papers or a motion that has been noticed for the calendar.

At Calendar Call each party should be prepared to make known or identify any plea offers, pre-trial motions in need of hearing prior to trial, time estimates for trial, interpreter requests, filed *Leaves of Absence*, and any matters which might impact the trial. The Court will also be available to take pleas at Calendar Call.

All motions the Court is requested to make a ruling on, conflict letters, and leave letters shall first be filed with the clerk's office before submitting a stamped filed copy to this Court's Judicial Assistant, Shanda DeLay, at email: sdelay@fayettecountyga.gov, and Staff Attorney, Ansley Whiten, at awhiten@fayettecountyga.gov.

PLEAS AND MOTIONS

Any attorney or unrepresented party who seeks to have a pending motion heard that relates to a criminal case on this calendar must file said motion by no later than July 31, 2026, notice it for hearing with a "Notice of Hearing" on August 3, 2026, and serve opposing counsel with said notice. Rule NISI's will not be accepted.

The Court will hear pleas on August 3, 2026, beginning at 9:00 a.m. Defense Counsel, if the Defendant you represent is entering a plea, please print out the plea paperwork the District Attorney's office sent you and bring it to the hearing with you for the Defendant to fill out and sign.

Motions not heard on or before August 3, 2026, shall be deemed waived unless a later hearing is expressly authorized by the Court.

Pleas after August 3, 2026, shall be considered non-negotiated, unless expressly permitted by the court as negotiated pleas.
