Calendar Call shall be held for the attached cases in Courtroom 2A of the Fayette County Courthouse on February 10, 2026.


9:00 a.m. - All Jail inmates and bonded defendants will appear in person for calendar call, and pleas. Attorneys are to also appear in person.

At calendar call, each party should be prepared to make known or identify any plea offers, pre-trial motions, time estimates, interpreter requests, leaves of absences, conflicts, and any matters which might impact trial. Defense attorneys must have already filed their criminal motions before this calendar call. Defense attorneys must file notices of motion hearings with the Court Clerk and serve the District Attorney's office with these motions and notices of hearings so their pre-trial motions can be heard.

Any plea cases already signed and ready at the calendar call shall be taken that day. If attorneys announce their cases will plea, the attorneys and defendants are to remain in court that day to sign up and take the plea case. Any plea cases after February 10, 2026, will be a blind plea. All jury trial motions will be heard on February 10, 2026. Any outstanding motions not heard by February 10, 2026, shall be deemed waived.

* This is a 2-week jury trial calendar, beginning at 9:00 a.m. on February 23, 2026. Unless instructed otherwise by the Court, every case is on 2-hour call during trial weeks. No one should report for trial until notified by the Court.
