A Calendar Call for all cases will be conducted on MONDAY, NOVEMBER 6, 2023, at 8:30 a.m. in Courtroom 2D. The parties may be excused from attending Calendar Call if the following information is provided in writing by mail, fax, hand delivery, or email ([tbarfield@fayettecountyga.gov](mailto:tbarfield@fayettecountyga.gov)) no later than 12:00 p.m. on MONDAY, OCTOBER 30, 2023:

1. Confirmation of Solicitor General's recommended sentence;
2. Confirmation that plea offer has been conveyed to the Defendant;
3. Plea recommendation and/or acceptance/rejection of plea recommendation;
4. Confirmation that deadline to accept a negotiated plea is FRIDAY, DECEMBER 1, 2023, UNLESS OTHERWISE NOTED on Exhibit "A,"
5. Anticipated length of trial; and
6. Any possible pretrial issues.

Motions shall be scheduled if filed. All motions shall be filed no later than TUESDAY, NOVEMBER 7,






