3. Plea recommendation and/or acceptance/rejection of plea recommendation;
4. Confirmation that deadline to accept a negotiated plea is FRIDAY, FEBRUARY 2, 2024, UNLESS OTHERWISE NOTED on Exhibit "A;"
5. Anticipated length of trial; and
6. Any possible pretrial issues.

Motions shall be scheduled if filed. All motions shall be filed no later than TUESDAY, JANUARY 9, 2024, 2023. **ALL DAUBERT MOTIONS MUST BE FILED BY JANUARY 9, 2024.**

Pleas for any cases on the February 2024 Jury Trial Calendar will be on FRIDAY, FEBRUARY 2, 2024, at 9:00 a.m. Upon request, there may be other opportunities to enter into a plea prior to FRIDAY, FEBRUARY 2, 2024.
